### Corporate Membership Information

A corporate membership shall be open to any business entity (corporation, partnership, sole proprietorship etc.).

Initiation fees and annual dues payable by a corporate membership shall be one hundred and fifty (150) percent of the senior membership.

A corporate membership shall have the right to designate up to three corporate representatives, which shall be valid as long as the corporate membership is in good standing.

Corporate representatives shall not have the right to vote or hold office and shall not have any proprietary rights in the assets of the society but may serve on society committees and volunteer.

### Procedure

All applications shall be posted on the society notice board for a period of seven (7) days, during which period senior and honorary life members in good standing may register their disapproval in writing to the executive if they consider that the applicant's membership will be contrary to the best interests of the society.

The executive shall consider the application and may grant membership by a majority vote of the executive.

Upon acceptance into the society the new member(s) will be notified.
